

Members of the Board present were Commissioner Whitewater, Commissioner Jenkins and Commissioner Hall.




AGENDA ITEMS:

1. A motion was made by Commissioner Jenkins and seconded by Commissioner Hall to accept a bid from APAC-Central, Inc. (Muskogee) for Highway 82C Project, length three (3) miles currently 18' wide, wanting to widen to 20' wide, start at Highway 82 go East for three (3) miles level pass with 2" overlay traffic control with signage, asphalt with trucking included, 6000 tons estimated "B" mix for District #1. Roll call: Commissioner Whitewater-yes, Commissioner Jenkins-yes, Commissioner Hall-yes. Motion carried.
2. A motion was made by Commissioner Hall and seconded by Commissioner Jenkins to approve a Purchase Agreement/Commitment to Lease for a John Deere 772 P-Tier Motor Grader with 6WD through Yellowhouse Machinery Co./Sourcewell, this is an agreement to hold the purchase price of \$349,680.57, as well as hold the trade-in value until the equipment is received for District #1, while the interest rate may fluctuate.
